The Town Board of the Town of Lyons met for a special meeting on March 25, 2020, at 12:00 p.m. in the Town Board meeting room.

This meeting was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town bulletin board and on the Town's web site.

Supervisor Emmel stated that the purpose of the special meeting was to approve the payment of bills from both the General and Highway funds. Because of the current Coronus virus situation, the State has mandated that no events containing more than 10 people will be allowed. As a result, the regular meeting, that would have been held tonight, has been canceled and all business scheduled for tonight will be rescheduled to the April meeting on the 29th. Supervisor Jake Emmel then presented the Board with prices for two trucks Highway Supt. Tim Moore would like to purchase this year through State contract pricing. He handed out the proposals and asked the Board to review. The matter would be discussed at a later Board meeting.

Supervisor Emmel also mentioned that bids for the mowing and landscaping of Town properties were received and opened at 10 a.m. today. Depending on weather conditions, a special meeting may have to be called to award the bids prior to the regular meeting in April. Bids were as follows:
