The Town Board of the Town of Lyons met for a regular meeting on Wed. April 28, 2022 In the Board room at the Lyons Town Hall.

This meeting was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town Bulletin Board and on the Town's web site.

Councilman Paliotti moved to accept the minutes from the March 30th meeting and from the April 14th workshop. Motion seconded by Councilman LaGasse. Vote:

The Board then discussed a request to repair the lighting on the Methodist Church clock. Lights on two sides of the clock are out and need repair. Plans were to convert the lights to LED but there was still questions in relation to the conversion. Mr. Bogan from A&A Electric stated that he and previous supervisor Mr. Emmel, spoke about converting the clock panels to LED which would be very little maintenance in the future. A&A Electric agreed to provide a written quote to do the west side of the clock.

The Board then discussed the growing concern of garbage and rubbish piling up around Town. This matter was discussed at an earlier workshop held by the Board. After another discussion, Councilwoman Greco-Eddy moved to hire Dave's Lawn Service at a cost of \$215.00 for two men with a pick-up truck and 2 men with a truck and trailer at a cost of \$265.00 and to hire Nardozzi Paving and Construction for the roll-off service for the deposit of the garbage and debris at the following costs:

cost of delivery: \$90.00
cost for rental: \$50.00/ month
cost per haul: \$250.00
cost per ton: \$51.00

In addition, there will be a Town administration fee of \$150.00.
