The Town Board of the Town of Lyons met for a meeting on Nov. 24, 2020, at 6:30 p.m. at the Lyons Community Center

This meeting was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town bulletin board and on the Town's web site.

All stood for the Pledge of Allegiance.

Councilman Brady moved to accept the minutes from the October 28, Nov. 4, and Nov 19, 2020 meetings. Motion seconded by Councilman Paliotti. Vote:

Councilman D'Amato then moved to approve the payment of General fund vouchers #558 through #610 totaling \$85,929.98. Motion seconded by Councilman Paliotti. Vote:

Councilman Brady then moved to approve payment of Highway fund vouchers #192 through #210 totaling \$25,394.86.

Joan Wallis, Town Planning Board member, then delivered the monthly Planning Board report to the Town Board. Among the items in the report....

- The board moved to not recommend giving a special permit to operate a kenneto Sherri Hutchinson of Montezuma Street.
- Keith Gardner made a presentation to the board detailing his proposed subdivision on Route 14 north of the "village." The subdivision would include 7 building lots with a road off Route 14 common to all 7 lots and running through each lot. The presentation was enhanced by the use of the Smart board, as Mr. Gardner presented and explained his subdivision map. The board requested that Mr. Villani be available to the Planning Board through the subdivision process.
- Mr. Villani then discussed with the board special permits and variances and the responsibilities of the Planning Board when considering requests for each.

Department reports were heard. Code Enforcement Officer Richard Bogan reported that from October 27, 2020, through November 20, 2020, the following activity was recorded:

Assessor Kayla Sturgill, in her written report stated total Property Transfers (Sales) in Oct. totaled 10 9 Arm's length usable for valuation purposes

1 quit claim(between family members, owner changes etc.)-not valuation usable

Agricultural renewals are on track to be sent out the end of November, beginning of December.

Senator Pam Helming has written a letter to the Governor asking him to sign an executive order that would suspend the renewal process for senior citizens for one year. These renewals usually get mailed closer to January 1. Ms. Sturgill will be holding off on them, waiting to see what the Governor does.

Apportionments will be done for town and county bills upon request.

Director of Ambulance Operations John Wiltsie reported a total of 146 in October 2020. Of those 110 were in Lyons. 22 in Newark and 8 to Clyde. Also, 6 were transports from the Newark Hospital back to the County Nursing Home.

Also, the brakes on the 2017 rig have been replaced.

Mr. Wiltsie also requested that some ALS supplies, medications, I.V. supplies be surpluses. He explained a couple of agencies are interested in the supplies. Councilman Brady then moved to declare the supplies surplus. Motion seconded by Councilman Paliotti. Vote:

Upon a request from Mr. Wiltsie, Councilwoman Greco moved to allow the expenditure of \$2,800.00 out of the donation account for new uniforms and boots for the ambulance employees. Motion seconded by Councilman Brady. Vote:

Highway Supt. Tim Moore reported that hot patching has been completed. Most of the new street signs have been installed, a few more yet to be placed. The pick up truck is on the road. Brush and leaf pick up continues, as weather permits. Snow plow markers have been placed around town and snow removal trucks are ready to go. The Wayne County Highway Dept. is cutting shoulders for the Town. Christmas decorations will be going up soon.

At 6:45 p.m., Councilman D'Amato moved to open the Public Hearing for the purpose of adopting a codification of the local laws, ordinances, and certain other resolution of the Town into a municipal code to be designated the "code of the Town of Lyons." Motion seconded by Councilwoman Greco. Vote:

The Public Hearing would remain open until all comments have been heard.

The necessary paperwork will be filed with the Secretary of State.

The first document is for agreement to the contract price for doing the work. The second, for the final payment to RoadTeck of \$22,141.44. And the third, for the final certificate of completion of the work. Motion seconded by Councilman Brady. Vote:
