Councilman LaGasse moved to accept the minutes of the January 11, 2023 meeting. Councilman Paliotti seconded. Vote:

Councilman DeWolf moved to approve the purchase of a Lyons Feather Banner for the Wayne County Bicentennial. The County is asking each town to purchase their banner. Councilman Bullock seconded. Vote:

Councilman LaGasse reviewed some ideas that the Lyons Town Planning Board discussed in relation to the Canalview Drive property that the Town owns. One member mentioned a town park while another discussed concerns with having an additional town park. Another suggested residential or townhouse properties. Councilman LaGasse makes recommendation to have townhouse development. The board agreed that this would be great opportunity for such being that it is on the canal. Some discussion ensued in relation to town owned property on Clyde Road.

Supervisor Brady mentioned the kickoff call with GAR Associates for the property revaluations. They reviewed the tentative schedule.

Councilman LaGasse discussed the annual Lyons Community Center funding. The town attorney requests that the town get together with the LCC to determine what programs the town could sponsor per say for the amount that is budgeted to the LCC. Councilmen DeWolf and Bullock will attend the next LCC board meeting to discuss.

Supervisor Brady informed the board that the Wayne County Water and Sewer Authority will compose a letter to go out to the residents in relation to the smoke testing of sewers. Once the letters are compiled, the town will mail them out.

Councilman DeWolf moved to schedule a public hearing to adopt a revised schedule of income eligibility levels for Real Estate Property Law 467 – partial tax exemptions for seniors on February 22, 2023 at 6:45 pm. Councilman Bullock seconded. Vote:
