The Town Board of the Town of Lyons met for a meeting on April 28, 2021 at 6:30 p.m. at the Lyons Community Center

This meeting was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town bulletin board and on the Town's web site.

All stood for the Pledge of Allegiance.

Councilman Brady moved to accept the minutes from the March 31 meeting as well as the April 21, 2021 workshop. Motion seconded by Councilman D'Amato. Vote:

Councilwoman Greco then moved to allow the Lyons Community Center to conduct a food truck and vendor fair at the Center on May 22, 2021 from 10 a.m. to 4 p.m. All necessary paperwork has been provided by the Center and has been approved by the Code Enforcement Officer, the Supt. of Highways, and Director of Ambulance Operations. Director of Ambulance Operations John Wiltsie reported: Calls: Town of Lyons: 137 Mutual Aide: Newark, 16 Town Sodus,1

Lyons Ambulance provided stand by coverage at Football games for Schools that used Lyons high school football field. We responded to all 911 calls if dispatched.

The Town of Lyons Ambulance is in full compliance under NYS DOH certifications Artical 30. The crews do a Part 800 check to make sure Ambulance is ready for calls.

If any tax payer has concerns or questions about the Town ambulance they are more than welcome to stop by and talk. My door is always open Mon-Thursday 9am-4pm. unless I am out on a call.

Starting Opening day of Lyons Farmers market the Ambulance will provide free Blood pressure checks. We plan on being there every Saturday 9am –ll am unless we have a call. Stop by meet the on duty crew. We will stage at William & Church St. Opening day June 19th, 2021.

Highway Supt. Tim More reported spring clean-up work is well underway. Both Town and former Village streets have been cleaned and brush is being picked up. A few large trees have been taken down. Brush grinding has final begun. Empire (Joe Bartucca) is doing that job. The drainage project at the fire hall is on-going and Mr. Moore is starting to figure out this year's paving and resurfacing projects. Mr. More asked if the Town was willing to pay Mr. Bartucca to grind what is now piled at the drop off site at the end of Clyde Rd. It would be an added charge as he has fulfilled his contracted amount of brush grinding. After a long discussion, the Board agreed to allow the extra grinding to be completed.

Councilman Paliotti then moved to schedule a Public Hearing at 6:45 p.m. at the May 26, 2021 Town Board meeting for Local Law 2-2021 for the reimbursement of Town expenses incurred for consultant and professional service. Motion seconded by Councilman Brady. Vote:

Councilman D'Amato moved to allow the Supervisor to sign a letter, asking for a one year extension for the delivery of approved engineering plans for the implementation of effluent disinfection at the wastewater treatment plant. Motion seconded by Councilwoman Greco. Vote:

The Board then discussed having a spring clean-up day. It was suggested that perhaps two days would suffice in an effort to allow residence to clean up their properties and bring items to roll-offs that would be made available at the Highway Barn on Clyde Road. After a long discussion on the matter, it was decided that the two days would be Wednesday June 9<sup>th</sup> from 9 a.m. to 3 p.m. and on Saturday June 12<sup>th</sup> from 9 a.m. to 1 p.m. Advertising will address which items will not be allowed.

Mr. Josh Perry then addressed the Board asking if the Town could install a few no littering signs on the south side of the former Village. He explained that he personally had picked up numerous bags of trash And believes those dumping their trash along the roadside and canal banks should face fines if caught and convicted. Supervisor Emmel said they would take care of it.

At 7:30 p.m., Councilman Brady moved to go into executive session, asking Assemblyman Brian Manktelow to remain. Motion seconded by Councilman D'Amato. Vote:

Councilman Brady then moved to authorize the Town Attorney to move forward to recoup expenses incurred with the demolition of a home on Broad Street last month, following a fire. Motion seconded by Councilman D'Amato. Vote:

Councilwoman Greco then moved that as the Town has received an appeal notice from Mr. James Wedman regarding the denial of some FOIL requested items, and as this is the first meeting since receiving the appeal letter, that the Town refer the matter to the Town Attorney for review and advice. Councilman D'Amato then moved that the Town appoint Councilman Brady and Councilwoman Greco to meet with two Town Planning Board members regarding the update of some Town codes and to report back to the Town Board at the May meeting. Motion seconded by Councilman Paliotti. Vote:
