The Town Board of the Town of Lyons met for a meeting on November 29, 2023 at 6:30 p.m. at the Town Hall.

Councilman Paliotti moved to accept the minutes of the October 25, 2023 meeting. Councilman LaGasse seconded. Vote:

Councilman LaGasse moved to accept the resignation of Ryan Robbins from the Planning Board effective immediately. Councilman Paliotti seconded. Vote:

Councilman Paliotti moved to re-appoint Michael Sinniger to the Board of Assessment Review. Councilman LaGasse seconded. Vote:

Deborah Hall from the Wayne County Historical Society was present to discuss the 111th NY Volunteer Infantry Memorial, Bronze Civil War Monument that they would like placed in the Town Park. She brought with her details of the monument and a Memorandum of Understanding which would be between the Wayne County Historical Society and the Town of Lyons.

Councilman LaGasse moved to authorize the draft of the Memorandum of Understanding and to approve Supervisor Brady signing as this is not a binding contract. Councilman Paliotti seconded. Vote:

Department reports were reviewed by the Town Board. Tim Moore, Highway Superintendent indicated that he was looking to purchase a new John Deere Cab Tractor.
