A number of people spoke on behalf and support of Carolyn Cook and the Helpful Hearts Community Closet and Soup kitchen. Many state that Helpful Hearts needs more space for the services that she is providing for not only this community but for surrounding communities within the county.

Supervisor Brady proposed a 6-month Moratorium to the town board in light of the recent award of the \$6,598,860 Restore NY Round 7 grant for the redevelopment of the Canal Street block. Mark Humbert of the Wayne County Landbank also spoke in reference to the grant. He explained that the Wayne County Landbank partnered with the Town of Lyons to apply for grants in relation to the Canal Street corridor. He explained that there will be upcoming studies/research in relation to what the best opportunities in that area are for the entire community.

Colleen Noble of Canal Street was present to discuss a bill that she received for time, equipment and town crew for pick up and removal of "excessive brush" removal which consisted of stumps, limbs, and branches from tree removals. The resident stated that the Highway Department had picked up a pile of around the same amount last year from trees/brush that they cleared away during the brush pick up days. She agreed with being charged for the oversized truck needed for removal but not the rest of the amount. She feels that it is an unfair amount and one that she does not want to pay.

Joanne Salerno introduced herself along with Mary Jones of Glow Up Girls. She wanted to bring forth her concerns with cannabis shops in our community. They wanted to ask the board to work on making changes.

William Pullen, Jr was present to speak on behalf of his parents who had received a violation notice and invoice for rubbish removal. Due to situations beyond their control, his parents did not get the information to William in a timely manner prior to the rubbish being removed and getting charges for the removal. William asked if the town would work with them and accept payments on the invoice seeing as how his parents are on a fixed income. The board agreed to arrangements. Councilman LaGasse

suggested waiving the Administrative Fee. Councilman Bullock moved to waive the Administrative Fee associated with the invoice. Seconded by Councilman LaGasse. Vote:
